The scholarships enable Hungarian students to pursue Graduate, Post Graduate, Doctoral and short term study programmes in select Indian Universities. Details of the scholarship programme and the procedure to apply are available on the UGC website, www.ugc.ac.in. Interested students from Hungary may apply for the scholarships in the prescribed application format. Relevant documents related to this programme are also enclosed herewith for your ready reference.

You are requested to kindly disseminate the information related to the scholarship programme on the relevant platform so that more Hungarian students can avail of the opportunities provided by this programme.

# INDO-HUNGARIAN SCHOLARSHIP PROGRAMME

## Call for Application for Hungarian Students

As per the provisions mentioned in the Indo-Hungarian Educational Exchange Programme, signed between the Ministry of Human Capacities of Hungary and The Ministry of Human Resource Development of the Republic of India on 19th November, 2014, the Indian Government through the University Grants Commission offers 35 scholarships for Hungarian students per year to pursue studies in select institutions of Higher Education in India.

## PROGRAMMES:

The Indian Government shall offer scholarships to 35 Hungarian students per year to pursue studies in India according to the following framework:

1. 10 scholarships for BA/BSc or MA/MSc studies per year for university Students for full-time studies in the English language. Students applying for these programmes shall have an appropriate knowledge of English on a certain level that is defined by the host institution.

Duration of the programmes: For BA/BSc-3 years and MA/MSc-2 years.

2. 5 scholarships per year for PhD studies in English language. Students applying for these programmes shall have an appropriate knowledge of English on a certain level that is defined by the host institution.

Duration of the programme: as per the regulations in force.

3. 20 scholarships per year for postgraduate courses primarily for Hindi language studies, or other disciplines and research. The part time scholarships may vary between 2 — 10 months.

Duration of the programme: as per the regulations in force.

## GENERAL PROVISIONS:

The scholarships are valid for studies in select Indian Institutions of Higher Education and for studies in fields defined in the Educational Exchange Programme. Scholarship holders must stay in India during the entire period of their studies or research. If necessary, scholarship holders may leave for one, maximum for two months at a stretch. In case of longer absence, the scholarship holder may lose her/his scholarship status.

## PROCEDURE TO APPLY:

Interested Hungarian students would first apply to Tempus Public Foundation, Hungary in the prescribed application format along with the relevant documents / certificates. Tempus Public Foundation shall nominate students and send the list to the UGC, India for admission in the select Indian Universities. The dead line for reaching the nominations at the UGC is 15th April, 2018.

## The applications must contain the following documents:

- 1. Application form (completely filled and signed by the applicant)
- 2. Curriculum Vitae
- 3. Certificate of the applicant's level of language necessary for the selected programme
- 4. Copies of the Mark sheets and Certificates from School leaving to the last examination passed.
- 5. Copy of the passport
- 6. Medical certificate of satisfactory health condition.

## FINANCIAL PROVISIONS:

The Indian party through University Grants Commission shall provide the following stipend to the selected students:

- Exemption from paying any fees for studies or research.
- Free appropriate accommodation for females only.

Note: - Travel expenses to India, within India and back to the country of origin shall not be covered by the Indian side.

The stipend may not be effectuated immediately upon arrival in India. Therefore, scholarship holders are advised to have sufficient amount of money to cover their living costs for at least two months in India. Apart from the outlined above, the Indian party shall not compensate for any other costs related to the scholarship holder's stay.

## CHANGE OF INSTITUTE/COURSE

As per scholarship rules, once a student opts for a particular university/course he/she is not allowed to change the course or the university/college/institute even if the duration and the tuition fee is the same. If any student is found violating this norm, his/her scholarship would immediately be cancelled.

#### FINANCIAL ENTITLEMENT

Payments to scholars are made as per the provisions mentioned at the Educational Exchange Programme between the two countries.

## RETURN JOURNEY TO HOME COUNTRY

Students should leave the country immediately after the completion of their studies. Under normal circumstances, the time gap between completion of studies and final departure should not exceed one month.

A scholar wishing to travel outside India during the course of study for personal reasons may do so at his/her own expense and with the prior permission of the institute where he/she is studying.

### CASES OF NON-ELIGIBILITY:

- Foreign citizens with a residence/immigration permit or in the course of applying for such a permit in India.
- Foreign citizens with permanent residence in India.
- Foreign citizens employed on a permanent basis in India.
- Applicants in employment applying for part-time or correspondence study programmes.

PhD programme applicants must attach the following documents in addition to the above:

- 1. Detailed research plan (min. 2 pages)
- 2. Two letters of recommendation
